Children 1st

Co-parenting Education Program for Divorcing and Separating Families

It has long been known that the most difficult part of the divorce process, for most children, is the prolonged and unresolved conflict that arises out of the parents' reaction to the pain of divorce/separation or to each other's behavior. The Children 1st program addresses these issues.

Through our data, we have identified that the #1 reason for students being referred to our counseling programs is due to parent separation and the trauma the student experiences from the loss of previous relationships.

Since our Partnership with the Hospice Giving Foundation and being able to utilize the Heal Together Grant we were able to expand our services from seeing clients on a 1 on 1 basis to hosting group events to be able to assist more people in one session. We were able to utilize some of the Heal Together funding to provide a barrier-free experience for all those who attended our classes. We did this by providing snacks, water, beverages, and a meal for all those that attended.

We provided individual teachers to the fathers' group, mothers' group, and children's group. In addition to the teachers, we provided child care for those children too young to receive the class. We wanted all those who attended the class to be able to immerse themselves in the education and have minimal distractions. Upon completion of the program, all participants receive a certificate of completion.

The goal of this service is to be a part of our community. We approached a few of the school districts that we work with to utilize their school sites to host our classes. We are happy to report that we partnered with school districts in Salinas, Greenfield, and King City to bring these classes to the community to serve their student population and others in the community willing to attend.

community willing to attend. This program has served over 300 parents and children and hosted over 20 groups all throughout Monterey County.

Sticks & Stones[®] and Community Counseling

Creating Waves of Impact

Our Sticks & Stones[®] school-based counseling program targets children and youth who have experienced trauma which is negatively impacting their overall functioning. The program uses evidence-based cognitive behavioral strategies to best address the trauma they may be holding, which if not addressed, can not only negatively impact learning opportunities, but also social and emotional functioning.

For the second year in a row, we have continued to experience a significant increase in the needs for our services. We experienced a shortage in staffing but were still able to serve hundreds of students. Returning from the pandemic, this year was the first full year back in person at the school sites. We witnessed the effects of how being deprived from social interaction has impacted students. This allowed us to identify changes in recommendation trends which led us to create our Comprehensive Social-Emotional Support (SES) package which has been implemented this year. This package was presented to all of our partners and it was well received.

We are excited to bring our school-based counseling programs, Bullying Prevention and Children 1st to most school sites.

Teen Success

In Support of Teen Moms and Babies

Harmony At Home's partnership program, Teen Success, has served as a safety net in the county for over 235 mothers and 180 children. This fiscal year alone we were able to support 181 individuals including 94 mothers and 87 children through individual and peer support sessions. Throughout the year, our dedicated Advocates completed various sessions with program participants. The focus was on supporting their path towards high school graduation and pursuing post-secondary education while breaking down barriers towards self-sufficiency. Together we celebrated many accomplishments including 25 graduations and program completions!

We are in awe of the resilience and perseverance our young moms demonstrate. It is evident that with reliable support young moms can accomplish their educational and life goals despite having a child at a young age. However, we have always wondered about the power of supporting the entire young family. Fathers often feel pressure to provide for their families and be a leader. Unfortunately, there are very limited support services available for them.

Harmony At Home understands the power of a father's role and association with his child's emotional and behavioral outcomes later in life. Both parents and legal guardians play a vital role in their child's life and deserve support towards a future full of possibilities. With that said and MUCH excitement, we are launching Harmony At Home's Family First Program this upcoming fiscal year, which will support not only young mothers but young fathers as well.

Family First aims to empower mothers, fathers, and guardians ages 15-25 who have not completed high school with the knowledge, skills, and confidence to raise the leaders of our future. Family First will partner with young families to support their education, parenting, and individual needs.

This program launch is a testament to our commitment to supporting young families in the community because we see their potential and know they have the biggest motivation looking up to them every day.

Bullying Prevention

Student-Led Assemblies Work

Harmony At Home's Bullying Prevention Program (HAHBPP) had significant rapid growth in the past year. Our Bullying Prevention Program has grown from a team of 2 to a team of 14, making this the largest team expansion in the program in over its decade of existence in Monterey County. Our newly hired and trained Bullying Prevention Coaches continue supporting our mission of assisting our schools and community with bullying prevention by supporting our students, parents, school staff and the community.

For the 2022-2023 school year, our Bullying Prevention Program supported a record number of students, staff and parents with bullying prevention services or with a Student Led Assembly (SLA). We are honored to say that we supported over 31,000 students from 52 schools in 13 school districts across Monterey County and the Aromas-San Juan area. Our Bullying Prevention Team supported our school partners with the implementation of SLA's, class meetings, one on one individual support, staff trainings, parent workshops that are provided in English and Spanish and with community events. The support that we provide to our school partners in bullying prevention is to ultimately help create a safe and positive climate and culture for our students to best learn.

For the first time:

• Bullying Prevention services are provided to the middle schools in the Salinas Union High School District (SUHSD) during the summer

• All of the high schools in the SUHSD will receive bullying prevention services for the 2023-2024 school year

• We served all Santa Rita Union School District (SRUSD) schools in 22/23

• First time receiving bullying prevention services: Lagunita School, San Benancio Middle School, Mission Elementary School, and Graves Elementary School



Teen Programs

Fostering Mental Health

Harmony At Home continues to provide hope and support to teens in our community through a number of existing and new programs.

During this past school year, we ramped up our partnership with Rancho Cielo to provide a full-time counselor at the Ranch. Seasoned counselor Vickie Avila was promoted to become Rancho Cielo's full-time counselor in January of 2023 and has not skipped a beat in providing amazing support to a much-needed population. Since January, Vickie has provided support to more than sixteen students, and has fostered a school culture that puts more emphasis on mental health. Her focus has been trauma-informed treatment which helps the youth process and work through their trauma with compassionate support, and ultimately envision the possibilities and opportunities that they can experience in their lives and recognize the importance of the choices they make today.

Over the past year, Seasoned Licensed Therapist Gail B. provided mental health support to twentysix youth ranging from freshmen to seniors from the Monterey County Office of Education (MCOE) alternative education program. This alternative education program, that we provide support for, will have all grade levels in the classroom, and not all of these students will meet the requirements for graduation. We are proud to report that one of these youths graduated from High School this year, which is quite an accomplishment considering most of the students who come to us are often behind in credits. Many have been excessively truant and/or been in Juvenile Hall. The success story is that they are actually attending school, which is a huge win. Due to excessive truancy and other challenges, our students often "age out" of high school without a high school diploma, but with the support and encouragement we provide now, the hope is that they will continue their studies posthigh school and achieve their educational success through an Adult Education program.

Following the unfortunate disruption of our Teen Enrichment Summer Camp programs due to the COVID pandemic, we are just now regrouping and getting back on track. Our partnerships with Rancho Cielo and MCOE are perfectly suited for recruiting both young men and women to be part of our summer camps.

COMMITMENT TO OUR MISSION

BREAKING THE CYCLE

How Savannah's journey influences those around her

Many of you have met or heard about Savannah Alvarez and learned how Harmony At Home helped her out of the darkness. But you may not know that she is now a proud mother to beautiful Grace Anna Lee. She was born in March 2023.

She has found her purpose in life: to take care of her baby. "My life is complete," said Savannah. "If anything ever happens to her, I will fall apart."

Her journey with HAH began when she was 16 years old. Her grandpa referred her to counseling. Savannah's stepdad was verbally and physically abusive to her. Her mom used drugs and alcohol—something that Savannah learned to mimic at an early age.

"A lot of women in my family are dysfunctional and left their children," she said. "I was afraid when I found out I was pregnant because I did not want this type of life for my child."

For many years Savannah lived with hate and resentment toward her mom. But at a HAH luncheon in 2013, she was a speaker and shared her story. Her mom was in the audience of 300+. It was at the end of her speech that Savannah looked at her mom and forgave her. The room was at a standstill as they embraced for the first time.

"I want my daughter to know about every struggle I have endured and teach her to be resilient, to not hold on to anger, and to know that forgiveness has healing power," she said. Savannah understands that her mom may not change her ways fully, but takes comfort in knowing that they now have a healthy relationship.

It was thanks to counselors like Julianne Leavy, summer camps, and other support offered at Harmony At Home that Savannah found ways to heal her soul which allowed her to live a life that at 16 she never could have imagined.

"Savannah is a shining example of a teenager hurting from severe trauma to a young woman who has truly come into her own in a magnificent way," said Julianne Leavy, President/CEO of Harmony At



Home. "Despite early childhood and adolescent trauma, Savannah was able to lean into the support that was presented to her and eventually find her path and thrive."

She is now a happy, kind, and full-of-life young woman who is influencing her family in a positive way. Her brother Isaiah is raising his children with principles his dad taught him and Savannah sees that it is possible for young men to be good parents.

She tells how her grandma once said that she could not imagine how children in her family could ever graduate high school and much

less consider college. Savannah proved her wrong. She acquired her GED making her the first in her family to graduate. She is currently attending Hartnell College and her goal is to become a math teacher for middle school-age children.

Now younger siblings and cousins are following in her footsteps. They are graduating high school and going on to college.

"Today she has broken the cycles of violence and abuse and is raising her daughter with exceptional parenting—she is offering Grace opportunities to thrive, grow, live, and learn in a nurturing environment," said Leavy.

At 34, she feels excited and filled with courage to take on raising her daughter and co-parenting in a healthy way to show Grace Anna Lee what 'healthy' looks like.

"It fills me with joy to witness Savannah love and care for her daughter with humble confidence, pride, and awareness of what it takes to raise an emotionally healthy child," Leavy said.

Savannah enjoys supporting youth in the community and talks to them about mental health and how important that is. She currently works for Interim Inc. supporting patients with therapy, meditation, and more. She is happy to be a mom and looks forward to traveling with her daughter and creating many memories together.

"Through all the support I got from HAH and Julianne, I am no longer afraid to be a parent," she said. "I will never leave her nor hurt her—I have this life education to get through anything together."

NOTES ON P&L for 22-23 Fiscal Year

The excess of revenue over expense for the 2022-23 fiscal year is primarily a result of grants received this fiscal year but intended to be spent in 2023-24, and an excess of program service revenue and grants received over actual operating costs. We budget for expenses conservatively such that if we experience difficult environments (such as economic downturns, unexpected loss of grant income due to the whims of government and private funders, events such as the recent pandemic, etc.), we remain in a position to fund our programs without interruption.

During 2022-23 we experienced no unforeseen events, and were additionally able to add efficiencies, and had unexpected fundraising success – all of which combined, resulted in a significant excess in revenue over costs. This excess will be used to fund additional services and program expansion, strengthen our infrastructure, and build our reserves to further guarantee the sustainability of our programs.
